Release and Waiver Agreement MESS (Litter Busters Club) Program

By signing this document, you waive certain rights including the right to sue. PLEASE READ CAREFULLY. TO: THE CORPORATION OF THE DISTRICT OF MISSION, ITS OFFICERS, EMPLOYEES, DIRECTORS and VOLUNTEERS AND THE MISSION ENVIRONMENTAL STEWARDSHIP SOCIETY (together called "THE RELEASEES").

ASSUMPTION OF RISK

I am aware that my child will be engaging in a MESS activity including those performed under the Litter Busters Club that may involve certain risks, dangers, and hazards, including, but not limited to picking up dangerous debris and collision with passing traffic. I agree to ensure my child is **always accompanied by a guardian** and **uses proper tools** (such as gloves, tongs and/or EZ Reachers) while participating to minimize any such risks and I freely accept, and fully understand and assume all risks and dangers and the possibility of personal injury, death, property damage or loss resulting therefrom including NEGLIGENCE, BREACH OF CONTRACT; OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT R.S.B.C. 1996, C.337 on the part of the Releasees.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

By participating in the MESS, Litter Busters Club program I hereby agree as follows:

- 1. TO WAIVE ANY AND ALL CLAIMS that I or my child have or may in the future have against the Releasees.
- 2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that my child may suffer or that my next of kin may suffer as a result of participating in the MESSociety Litter Busters Club program due to any cause whatsoever, including negligence on the part of the Releasees and including NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT R.S.B.C. 1996, C.337 on the part of the Releasees.
- 3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES for any and all liability for any property damage or personal injury to any third party, resulting from my child's participation in the program.
- 4. This Release shall be effective and binding upon my child's heirs, next of kin, executors, administrators and assigns, in the event of my child's death.

I have read this Release prior to signing it and I understand its effect. I am aware that by signing this Release I am waiving certain legal rights which my child or next of kin, executors, administrators and assigns may otherwise have had against the RELEASEES.
