



Join us on Saturday, April 22nd, 2023 from 10am – 2pm at Fraser River Heritage Park to celebrate earth day at Green Living! Our goal is to inspire environmental stewardship & sustainable living amongst local citizens through awareness, engaging activities, & guest speakers. We invite all local environmental or community groups, green businesses, food vendors, local artists, & entertainers to apply. All exhibitors must have a green purpose or interactive activity. Each exhibitor will need to supply their own tent, table or booth as this is an outdoor event. We ask that all groups implement the theme of hope to encourage positive change. All business vendors must sell environmentally friendly goods & services to be accepted as a vendor. We discourage the use of any single use plastics including disposable plastic cups, straws, containers, utensils & bags. We encourage all vendors to use compostable or biodegradable containers or bags. For-profit vendors will be juried prior to being accepted as a seller. Please list information of what you plan to sell and photos are also helpful. If you are a community group or non-profit and do not have a tent, please contact us as there *may* be some sheltered space or an extra tent that we can assist you with. Tent spikes are not allowed due to underground electrical and all exhibitors will be asked to use weights for their tents. **This is an outdoor event and will proceed rain or shine.**

Exhibitors will be able to drive up to their booth space to drop equipment off for set up prior to the opening of the event from 8-9:30AM. Tear down time will start at 2PM once the event closes. All exhibitors must have their cars parked in the designated parking lot no later than 9:30AM prior to guests arriving. The parking lot will be by donation.
